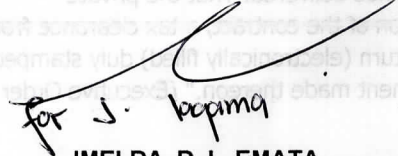

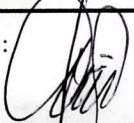

## **RESOLUTION TO AWARD**

**WHEREAS**, the City Government of Pasig, through the Bids and Awards Committee (BAC), posted and issued an Invitation to Bid (ITB) for the **SUPPLY AND DELIVERY OF MEDICAL OXYGEN (REFILL ONLY) 125 lbs -PCGH** in accordance with Section 21 of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 with an Approved Budget for the Contract of FIVE MILLION FOUR HUNDRED SIXTY-NINE THOUSAND FIVE HUNDRED TWENTY PESOS (Php5,469,520.00);

**WHEREAS**, the ITB was posted at the websites of the City and the Philippine Government Electronic Procurement System (PhilGEPS), as well as in a conspicuous bulletin board within the premises of the City Government of Pasig;

**WHEREAS**, a pre-bid conference was conducted on 29 June 2022 to discuss the conduct of public bidding and the contents of the Bidding Documents, wherein three (3) prospective bidders attended;

**WHEREAS**, one (1) bidder bought the bidding documents for the project;

**WHEREAS**, one (1) bidder submitted the eligibility requirements, technical and financial proposals on the scheduled time and date;

**WHEREAS**, in compliance with Section 13 of the IRR of R.A. 9184, the BAC sent an invitation to the Commission of Audit ("COA") and observers to participate in the various procurement proceedings;

**WHEREAS**, despite such notice, no COA representative and observers were present during the bid opening on 13 July 2022 and the BAC proceeded with the same pursuant to Section 13.3 of the IRR of R.A. No. 9184;

**WHEREAS**, after the Opening and Preliminary Examination of the First (1<sup>st</sup>) Bid Envelopes (Eligibility and Technical Component of the Bid), PENTAGON GAS CORPORATION got "Passed" rating and is qualified for the opening of the second (2<sup>nd</sup>) bid envelope;

**WHEREAS**, upon completion of the Opening and Preliminary Examination of the Second (2<sup>nd</sup>) Bid Envelopes (Financial Component), PENTAGON GAS CORPORATION was found compliant with the bidding requirements prescribed in the IRR of R.A. No. 9184 with a Bid Price of Php5,093,520.00;

**WHEREAS**, the BAC conducted detailed bid evaluation on 15 July 2022 wherein the BAC declared the bidder as the Single Calculated Bid (SCB), detailed as follows:

**WHEREAS**, thereafter, the BAC-Technical Working Group (BAC-TWG) for Medical conducted post-qualification assessment on 02 August 2022 and found that **PENTAGON GAS CORPORATION** passed all the criteria for post qualification;
