# Description

#### INVITATION TO BID

The City Government of Pasig through Ordinance No. 38 Series 2021 dated October 28, 2021 duly approved by the Sanggunian Panglungsod appropriated funds in the sum as enumerated below being the Approved Budget for the Contract (ABC), invites potential Bidders to bid for the project:

1 Installation of LED Tapered Streetlights at Various Locations, Brgy. Buting, Pasig City 3,951,258.70 (120)

Bidders shall possess a valid Philippine Contractors Accreditation Board (PCAB) license applicable for each of the above type and cost of the contract, have completed a similar contract with a value OF AT LEAST 50% of the ABC. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bids received in excess of the ABC shall be automatically rejected at bid opening.

All particulars relative to Eligibility Check, Bid Security, Evaluation of Bids, Postqualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised IRR.

The place of all bidding activities shall be at the Pasig City Hall on the following schedules:

1 Issuance of Bid Tender Documents only to Eligible bidders upon payment of a non refundable fee of an amount as per Revised IRR of R.A. 9184 September 14, 2022 to October 3, 2022 Until 10:00 A.M. BAC Secretariat Office, 4th Floor

3 Submission and Receipt of the Technical and Financial Proposals October 3, 2022 Until 10:00 A.M. BAC Secretariat Office, 4th Floor

4 Opening of the Technical and Financial Proposals October 3, 2022 at 10:00 A.M. Meeting Room, 7th Floor

Late bids shall not be accepted.
