**WHEREAS**, Clemente Santos is the registered owner of a parcel of land covered by Transfer Certificate of Title No. 90487 containing an area of 27,918 square meters located at Barangay Bambang, Pasig City;

**WHEREAS**, portion of the above parcel of land with an area of **388** square meters was converted into road now called Farmer's Avenue, Brgy. Bambang, Pasig City but he has not been paid nor compensated by the City Government of Pasig up to the present time. Hence, the property owner, duly represented by surviving heirs is requesting the City Government of Pasig for the payment of just compensation on the said property;

**WHEREAS**, the Gross Amount of Four Million Two Hundred Sixty Eight Thousand Pesos (Php. 4, 268, 000.00) shall be paid to the registered owners/lot owners as agreed upon by both parties;

**WHEREAS**, the budgetary requirement to implement this Ordinance shall be chargeable to the Supplemental Budget No. 1, Series of 2021, as certified by the City Budget Office, and subject to existing COA rules and regulation.

**WHEREAS**, under Section 19 of Republic Act No. 7160 provides that, a local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the constituents of Pasig, upon payment of just compensation;

WHEREAS, the budgetary requirement to implement this Ordinance shall be chargeable to the Supplemental Budget No. 1, Series of 2021, as certified by the City Budget Office, and subject to existing COA rules and regulation.

WHEREAS, under Section 19 of Republic Act No. 7160 provides that, a local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the constituents of Pasig, upon payment of just compensation;



NOW THEREFORE, be it RESOLVED, as it is hereby RESOLVED by the Sangguniang Panlungsod in a session duly assembled the following:

Section 1. The City Mayor, Honorable Victor Ma. Regis N. Sotto, is hereby authorized the payment for just compensation to the affected lot owner Clemente Santos, duly represented by heirs and enter into and sign, for and on behalf of the City Government of Pasig, a corresponding Deed of Absolute Sale of the above property affected by the construction of road taking into consideration the recommendation of the City Appraisal Committee of the City Government of Pasig, subject to existing COA accounting rules and regulations.

Section 2. The amount to be used for the payment of just compensation shall be taken from the land capital outlay of the City Government of Pasig under Supplemental Budget No. 1, Series of 2021.
