MEMORANDUM OF AGREEMENT

*FOR THE TURN-OVER AND MAINTENANCE OF THE STREET LIGHTING FACILITIES
OF BONIFACIO GLOBAL CITY-ORTIGAS CENTER ROAD LINK PROJECT, PASIG CITY*

KNOW ALL MEN BY THESE PRESENTS:

This **MEMORANDUM OF AGREEMENT** entered into and executed this _____ day of _____ by and between:

DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, a government agency existing under the laws of the Republic of the Philippines, with office address at Bonifacio Drive, Port Area, Manila, duly represented in this Agreement by Secretary, **MARK A. VILLAR**, hereinafter referred to as "**DPWH**".

The **LOCAL GOVERNMENT OF PASIG CITY**, a local government unit of the Republic of the Philippines with office address at 8th Floor, Pasig City Hall Building, Caruncho Street, Pasig City, Metro Manila, duly represented in this Agreement by Mayor, **VICTOR MA REGIS NUBLA SOTTO**, hereinafter referred to as "**LGPC**".

WITNESSETH THAT:

WHEREAS, the **BONIFACIO GLOBAL CITY-ORTIGAS CENTER ROAD LINK PROJECT** was inaugurated and opened to traffic on 12 June 2021;

WHEREAS, the Street Lighting Facilities of the project (hereafter referred to as the Facilities) need to be properly maintained and kept operational at all times;

WHEREAS, the Facilities, already energized and equipped with MERALCO meter, will be turned-over to LGPC to ensure the continued operation and proper maintenance thereof;

NOW, THEREFORE, in view of the foregoing premises and in consideration of the mutual covenants hereunder, the Parties hereto hereby agree as follows:

Section I: **RESPONSIBILITIES OF DPWH**

1. To turn-over the Facilities to the LGPC upon the signing hereof and furnish the LGPC with the As-Built drawings of the Street Lighting System of the Project.
2. To secure or cause the securing of all permits, pay all fees required for the works and furnish the LGPC with the Certificate of Electrical Inspection and approval from the proper government authorities for completed works.
3. To settle fully the unpaid bills for electricity consumption during the operation of the Facilities prior to the turn-over thereof to the LGPC.

Section II: **RESPONSIBILITIES OF LGPC**

1. To pay the bills for electricity consumption of the Street Lighting Facilities from the date of turn-over thereof; and
2. To maintain the Street Lighting Facilities from the issuance of the Certificate of completion to the contractor of the project.

Section IV: **EFFECTIVITY**

This Memorandum of Agreement shall take effect upon ratification hereof by the Sangguniang Panlungsod of Pasig City and shall remain valid and in full force and effect until revoked or superseded.

IN WITNESS WHEREOF, the parties hereto have signed this Agreement on the date first written above.
