**WHEREAS**, Section 454 (d) of the same code provides that, the City Legal Officer shall be appointed by the City Mayor with the concurrence of the majority of all Sanggunian members;

**WHEREAS**, on 1 July 2022, the City Mayor renewed the appointment of Atty. Josephine C. Lati-Bagaoisan as the City Legal Officer, hence, the concurrence of the majority of the members of the Sanggunian needs to be obtained;

**NOW, THEREFORE**, on motion duly seconded, the Sangguniang Panlungsod resolves, as it hereby resolved, to confirm the appointment of Atty. Josephine C. Lati-bagaoisan as the City Legal Officer of the City Government of Pasig, effective July 1, 2022.
