**WHEREAS**, the eight (8) poor and underprivileged families located at Cuevas Compound, Brgy. San Joaquin, are subject for eviction by virtue of the sale of the property, and that they should vacate the subject property's premises;

**WHEREAS**, the affected families have been duly validated by the City Social Welfare and Development Office as poor and underprivileged, as defined in RA 7279 or the Urban Development and Housing Act of 1992 (UDHA);

**WHEREAS**, to ease to burden of the other members of the community, and to aid them in their plight, the City Government of Pasig deems it necessary to grant financial assistance to them in this time of need;

**WHEREAS**, the City Government of Pasig shall provide financial assistance in the amount of Ten Thousand Pesos (Php10,000.00), for each of the eight (8) affected families as listed below:

**RESOLVED FINALLY**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing COA rules and regulations.


