**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR VICTOR MA. REGIS N. SOTTO TO ALLOCATE THE AMOUNT NOT TO EXCEED THREE HUNDRED FIFTEEN THOUSAND PESOS (PHP 315,000.00) TO HELP DEFRAY THE COST OF ELECTRICAL CONSUMPTION OF THE STREETLIGHTS OF VALLE VERDES I, II, III, IV, V, VI AND VII, BARANGAY UGONG, PASIG CITY, EFFECTIVE JULY 1, 2022 AND EVERY MONTH THEREAFTER.**

**WHEREAS**, street lighting is a strategy of the City Government to reduce crime and disorder alongside other physical and social improvements;

**WHEREAS**, streetlights helps drivers see the location on side roads, reveal signs and hazards and make residents of all genders less fearful of crime or more confident of their own safety at night;

**WHEREAS**, the request of aforesaid homeowner's association is meritorious and well-taken considering the crucial importance of streetlights on main roads;

**NOW, THEREFORE** on motion duly seconded, the City Council resolves, as it is hereby resolved, to authorize the Honorable City Mayor Victor Ma. Regis N. Sotto to allocate the amount not to exceed Three Hundred Fifteen Thousand Pesos (Php 315,000.00, in which every phase of Valle Verdes shall receive the amount of Forty Five Thousand Pesos (Php 45,000.00), to help defray the cost of electrical consumption of the streetlights of Valle Verdes I, II, III, IV, V, VI and VII, Barangay Ugong, Pasig City, effective July 1, 2022 and every month thereafter. Provided, however, it is with the condition that any amount in excess hereof shall be the responsibility of Valle Verde I, II, III, IV, V, VI and VII and that any amount less hereof shall be convertible to cash.

**RESOLVED, FURTHER**, that the budgetary requirement to implement this Resolution shall be chargeable against any available funds in the City Treasury, subject to existing rules and regulations of the Commission on Audit.



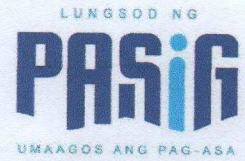

Cruz and with the presence of representatives of concern offices Budget Office, Treasury Office, Office of General Services Office, Resolution entitled "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR VICTOR MA. REGIS N. 2. The said amount will help defray the cost of The Subdivision Street Light Consumption every month.
3. That such streetlight would be beneficial to the constituent of the said Subdivision Valle Verde I, II, III, IV, V, VI, and VII in the reduction of crime rate and disorder alongside other physical and social improvements; it would also help drivers see the location on side roads, reveal signs and hazards and make residents of all genders less fearful of crime or more confident of their own safety at night.
4. The budgetary requirement to implement this Resolution shall be charged against any available funds in the City Treasury, subject to existing COA rules and regulation.
5. This resolution shall be passed on second reading on the 28<sup>th</sup> day of July 2022.
