A RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF PASIG THROUGH THE HONORABLE CITY MAYOR VICTOR MA. REGIS N. SOTTO TO ENTER INTO AND SIGN A DEED OF DONATION WITH ACCEPTANCE WITH MILO PHILIPPINES FOR THE DONATION OF ITEMS TO BE USED IN THE CITY GOVERNMENT OF PASIG'S FREE GRASSROOT SPORTS CLINIC.

WHEREAS, Article XIV of the 1987 Philippine Constitution provides that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that every local government unit shall ensure and support, among other things, the promotion of health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, Milo Philippines, through its Representative, Carlo M. The initial hearing on July 25, 2022 at the Meeting Room 7th Floor Pasig City Hall, with the presence of Councilor Mark Gil Delos Santos, Councilor Maria Luisa De Leon, Councilor Quin Cruz, Councilor Syvel Asilo, Councilor Raymund Francis Rustia, Councilor Corazon M. Raymundo, Liga Pres. Rigor Enriquez, SK Fed. Pres. Georgia Lynne Clemente and with the presence of representatives of all concerned offices, Education Unit, Budget Office, and Treasury Dept. with the following Proposed Resolutions which was discussed to wit:

1. A proposed Resolution authorizing the City Mayor, Hon. Victor Ma. Regis N. Sotto to grant financial assistance to Philippine Sports Association for the Differently Abled (PHILSPADA) in the amount of Seventy Thousand Pesos (Php 70,000.00), where athletes and their coaches will proportionately receive the amount of Ten Thousand (Php 10,000.00) to help defray the cost of its participation in the 11th ASEAN Para Games 2022, in Solo, Indonesia on July 30 to August 6, 2022 and for other purposes:


