WHEREAS, the five (5) informal settler families are located at J.B. Miguel St., Brgy. Bambang, are subject to judicial proceedings, wherein the court ordered, with finality, that they should vacate the subject property;

WHEREAS, the said informal settler families have been duly validated by the City Social Welfare and Development Office as underprivileged and homeless, as defined in RA 7279 or the Urban Development and Housing Act of 1992 (UDHA);

WHEREAS, in coordination with the Pasig Urban Settlements Office ("PUSO"), these informal settler families are invoking the provisions of the UDHA and are requesting assistance from the local government;

WHEREAS, to ease the burden of the other members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA;

WHEREAS, the City Government of Pasig shall provide financial assistance in the amount of Thirty Four Thousand Two Hundred Pesos (Php 34,200.00), equivalent to the prevailing minimum wage times sixty (60) days, to comply with the provisions of the UDHA for each of the five (5) affected families as listed below:

- 1. Cocheza, Dolores Rodriguez
- 2. Cagalingan, Emelito Bozon
- 3. Mabini, Marivic Gonzales
- 4. Rodriguez, Bonifacia Menguito
- 5. Junsay, Shirley Ortiz

**NOW, THEREFORE,** on session duly assembled, the Sangguniang Panlungsod resolves, as it hereby resolved, that the Honorable City Mayor Victor Ma. Regis N.
