WHEREAS, a few buildings which have been constructed recently in different school campuses remained without being named;

WHEREAS, the Pasig School Board has taken appropriate steps through the formation of a Technical Working Group on the naming of Newly-Constructed School Buildings in honor of esteemed Pasiguenos as who have brought honor and contributed greatly to Pasig and have since made a proposal to that effect;

WHEREAS, the Sangguniang Panlungsod recognizes the importance of naming the newly-constructed school buildings and is in full accord with the proposal of the Local School Board.

NOW, THEREFORE, for and in consideration of the above premises, the Sangguniang Panlungsod duly assembled, do hereby

RESOLVE, AS IT IS HEREBY RESOLVED, to authorize the Office of the City Mayor to assign names of prominent Pasiguenos as to the newly-constructed school buildings in Pasig City.
