WHEREAS, to ease to burden of the other members of the community, and to aid them during this time of pandemic, the City Government of Pasig deems it necessary to grant financial assistance to them based on the provisions of the UDHA;

WHEREAS, the City Government of Pasig shall provide financial assistance in the amount of Thirty Four Thousand Two Hundred Pesos (PhP34,200.00), equivalent to the prevailing minimum wage times sixty (60) days, to comply with the provisions of the UDHA for each of the ten (10) affected families as listed below:
