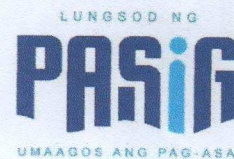

**COMMITTEE REPORT**

The hearing on August 22, 2022 at the Session Hall Plenary Hall, 7th floor, Pasig City Hall, with the presence of Councilor Mark Gil Delos Santos, Councilor Maria Luisa De Leon, Councilor Paul Roman Santiago, with the presence of the OIC budget officer with the Proposed Resolutions adopting Panukalang Kapasiyahan Blg. 30-2022: A Resolution Authorizing The Honorable City Mayor, Victor Ma. Regis N. Sotto To Grant Financial Assistance In The Amount of One Million One Hundred Nine Thousand Three Hundred Pesos (Php 1,109,300.00) To Pasig City King Pirates For Their Participation In Philippine Chess Association Of The Philippines (PCAP), And For Other Purposes.

After a careful study, the following resolutions were finalized:

1. The Philippine Chess Association - Pasig City King Pirates are asking for financial assistance amounting to P1,109,300.00 as reimbursement for their participation during the PCAP. The professional tournament ran from eliminations to quarter finals to semi-finals, until the championship round.
2. There was a total of 24 participants that were divided through their geographic region (north and south). Pasig City King Pirates became the overall champion and represented the north region for the championship round. The tournament was a yearlong event consisting of 3 tournament conferences.
3. The Pasig City King Pirates deployed 7 out of 11 players in total (top 2 grandmasters, 1 master, and so on). Pasig City became the team to beat this year as they were declared as the champion from the north region.
4. This committee approved this report, recommends for its adoption and this resolution be passed on second reading, next session that will be held on the 25th day of August 2022.
