A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE VICTOR MA. REGIS N. SOTTO, TO ENTER INTO AND SIGN A DEED OF DONATION BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES AND THE LOCAL GOVERNMENT UNIT OF PASIG CITY, AND FOR OTHER PURPOSES.

**WHEREAS**, the DENR-EMB is the lead agency in the implementation of Solid Waste Management (SWM) in the country in coordination with other partners and stakeholders to provide guidance and technical assistance on concerns on waste management strategies and options to LGUs;

**WHEREAS**, Solid Waste Management is a pervasive problem and a looming crisis in many areas in the Philippines, focusing for decades on collection and hauling and not on waste treatment and disposal, thus it has become very expensive;

**WHEREAS**, many well-meaning projects, laws, rules and regulations have achieved little so far with Local Government Units (LGUs) facing a massive challenge in managing rapid and largely unplanned urban growth;

**WHEREAS**, Section 8 of R.A. No. 9003 states that the Department shall provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

**WHEREAS**, after 20 years of implementation of RA 9003 or the Ecological Solid Waste Management Act of 2000, continuing challenges exist in solid waste collection, establishment of material recovery facilities (MRF), the lack of enforcement of the basic requirements of RA 9003 and poor solid waste diversion;

**WHEREAS**, in order to support the LGUs, the DENR freely and voluntarily gives, conveys and transfers by way of donation the plastic shredder machine, plastic washer, plastic dryer machine, plastic extruders, hydraulic press machines, cooling tubs, plastic chair molds, pollution control system, accessories and other tools and parts per set as indicated in the Deed of Donation;

**WHEREAS**, the partnership between the DENR and Pasig City Local Government will lead the city to more sustainable environment and balanced ecology;






**RESOLVED, FURTHER,** that the copies of the Deed of Donation shall form an integral part of this Resolution.







**Salient Points Discussed:**


- The Department of Environment and Natural Resources (DENR) chose Pasig City as the recipient of a set of plastic recycling equipment as it was one of the first three local government units that was able to comply with its requirements. The set of equipment was delivered in April 2021, placed at the Materials Recovery Facility (MRF) of Barangay Bagong Ilog and has been functional since, recycling soft plastics into components that can be constructed into school chairs. To date, less than one hundred (100) chairs have been assembled.
- Because the set of equipment is still under warranty, any issues or breakdowns are dealt with by the supplier. Once the Deed of Donation is signed and the equipment becomes property of the City Government, all maintenance costs will be shouldered by the City.
- Due to the equipment's limitations, the operators have encountered problems when the wrong type of plastics are fed into the shredders. The finishing process has proven to be tedious as well since it is necessary to polish and paint the chairs in order for them to be fully-functional. The City Solid Waste Management Office (SWMO) has allocated funds to procure supplies to finish the chairs.
- Concerns were raised about whether the equipment will be useful and beneficial to the City in the long run. The resource person explained that the equipment was given to the City at no cost. The benefits still outweigh future costs that may be incurred. It can be part of a learning hub where students can learn how Pasig City treats its plastic waste. It can also be showcased as an important component in our City's transition to a circular economy.
