The following are the crucial points of discussion raised during the interpellation:

1. Electronic transactions like e-wallet top-up, paying bills, and buying electronic load have been a popular mode of financial transaction given its convenience. Accordingly, the City Government of Pasig seeks to provide such convenience to its constituents.
2. Although the proposed Automated Payment Terminal (APT) is planned to be installed within the premises of the Pasig City Hall, it can be utilized by both employees and non-employees of the City Government of Pasig.
3. In terms of responsibility of each party, it was clear that the City Government of Pasig is responsible for three things – 1) providing location for the deployment of the APTs; 2) electricity, and; 3) the reporting of the physical status of the APT to the Corporate Information Solutions (CIS) Bayad Center, Inc.
4. Other matters concerning the APTs such as maintainance, theft, risks, and untoward events that may affect the performance of the machine are to be shouldered by the company. However, security risks are considered to be lessened since the APTs will be deployed within the premises of the Pasig City Hall.
5. Transaction fees will depend on the biller, not on CIS Bayad Center, Inc. The latter is to remit money to the City Government on a monthly basis regardless of the number of transactions made within that period.

COMMITTEE RECOMMENDATION:

This Committee has considered the same and has the honor to report back to the 11th Sangguniang Panlungsod with the following recommendation:

1. Indicate the expanded meaning of “CIS” as Corporate Information Solutions;
2. Change the last preambulatory clause to “WHEREAS, the Sangguniang Panlungsod recognizes the purpose of such request and grants the power to the Local Chief Executive to sign the said contract on behalf of the City, effective from August 1, 2022 to July 31, 2025 subject to the terms and conditions stipulated in the contract.”

3. Change the first operative clause to "NOW, THEREFORE, on a motion duly seconded, the Sangguniang Panlungsod hereby resolves, as it is hereby resolved, to authorize Honorable City Mayor Victor Ma. Regis Sotto to sign the Memorandum of Agreement with CIS Bayad Center, Inc.
4. Once all the revisions have been adopted, the Committee unanimously recommends that this Resolution be considered urgent and expeditiously passed for second and third reading.
