



**EXECUTIVE ORDER NO. PCG- 26
SERIES OF 2022**

**AN EXECUTIVE ORDER RECONSTITUTING THE PASIG CITY DEVELOPMENT
COUNCIL, DEFINING ITS FUNCTIONS, AND FOR OTHER PURPOSES**

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the organization of the City Development Council (CDC);

WHEREAS, there is a need to reconstitute the City Development Council to strengthen the institution in setting the direction of the economic and social development, and coordinating development efforts, at the local level;

WHEREAS, Barangay participation in the City Development Council as provided for under Section 107 (b) of Republic Act No. 7160 would afford active participation in the formulation of development programs and projects;

WHEREAS, JMC No. 01 s. 2007 of the DILG, National Economic and Development Authority (NEDA), Department of Budget and Management (DBM), and Department of Finance (DOF), provides for the synchronization and harmonization of planning, investment, programming, revenue administration, and budgeting and expenditure management at the local level;

WHEREAS, in recognition of the need to provide opportunities to the private sector and civil society organizations to participate in the local development process and in preparing/approving the multi-sectoral development plans of the LGU, the City had already expanded the membership of the CDC from 2019-2022;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, Mayor of the City of Pasig, by virtue of the power vested in me by law, do hereby reconstitute and mobilize the Pasig City Development Council, to wit —

SECTION 1. Composition. — The Pasig City Development Council shall be composed of the following members:

SECTION 2. Duties and Function of the CDC. – The City Development Council shall exercise the following functions:

- a. Formulate long term, medium term and annual socio-economic development plans and policies;
- b. Formulate the medium term and the annual investment program;
- c. Appraise and prioritize socio-economic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and directions of private investment capital;
- e. Coordinate, monitor, and evaluate the implementation of development programs; and
- f. Perform such other functions as may be provided by law or competent authority.

SECTION 3. Meetings. — The City Development Council shall meet at least twice a year or as often as may be necessary.



SECTION 4. Executive Committee. — The City Development Council shall, by resolution and within three (3) months from the date of its reconstitution, create an Executive Committee to represent and act on behalf of the City Development Council when it is not in session;

SECTION 5. Composition of the CDC Executive Committee. — The CDC Executive Committee shall be composed of the following:

SECTION 6. Duties and Functions of the CDC Executive Committee. — The CDC Executive Committee shall exercise the following powers and functions:

- a. Ensure that the decisions of the CDC are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the CDC;
- c. Formulate policies, plans and programs based on the general principles laid down by the CDC;
- d. Take action on matters that maybe authorized by the CDC except the approval of the development plans and annual investment plans.

SECTION 7. Meetings of the CDC Executive Committee. — The Executive Committee shall hold meetings as the needs arise. Special meetings may be called by the Chairperson or by a majority of its members.



SECTION 8. Sectoral Development Committees. — The City Development Council shall organize its Sectoral Development Committees representing the Social, Economic, Infrastructure, Environment, and Institutional Development Sectors to provide planning support to the CDC and the CDC Executive Committee. Membership in the Committees shall be as follows:

SECTION 9. Functions and Duties of the Sectoral Development Committees. The CDC Sectoral Development Committees shall exercise the following powers and functions

- a. Gather primary or secondary data and review available sectoral plans required in the preparation of plans;
- b. Generate data and analyze them into relevant information for purposes of updating of the local plans;
- c. Assist the CDC in drafting and finalizing local plans;
- d. Participate in relevant workshops for updating and formulation of local plans and policies;
- e. Provide recommendations necessary for the updating and formulation of plans and policies.

SECTION 10. Meetings of the Sectoral Development Committee. — The Sectoral Development Committees shall hold meetings as the needs arise.

SECTION 11. Secretariat. — A Secretariat which shall be responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing such assistance as maybe required by the CDC is hereby constituted and shall be headed by the City Planning and Development Officer and shall consist of a core group from the City Planning and Development Office and staff from the other offices as may be deemed necessary. The Secretariat shall consist of a Technical Group and an Administrative Group.



SECTION 12. Honoraria. – Members of the CDC, CDC Executive Committee, and CDC Sectoral Development Committees who are not employees of the City Government, such as representatives from accredited CSOs, private sector, and national government agencies, shall be entitled to receive honoraria as may be authorized by law, circular, or existing guidelines; *provided*, that honoraria may only be paid on the basis of actual and personal attendance.

SECTION 13. Repealing Clause. – All other orders or issuances inconsistent herewith are hereby repealed, amended, or modified accordingly.

SECTION 14. Dissemination. – Copies of this Executive Order shall be furnished within seventy-two (72) hours from its issuance to the Office of the President and the Metro Manila Development Authority for information and guidance, pursuant to Sec. 455(1)(xii) of the Local Government Code, as amended.

SECTION 15. Effectivity. – This shall take effect immediately.
