The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post qualification of the lowest calculated bid shall be conducted.

All particulars relative to post-qualification / eligibility, bid security, performance security, pre-bid conference, bid opening, bid evaluation and award shall be governed by the provisions of RA 9184, and its Implementing Rules and Regulations.
