



EXECUTIVE ORDER NO. PCG-007
Series of 2022

AN ORDER CONSTITUTING THE PASIG CITY INFRASTRUCTURE AUDIT TEAM

WHEREAS, the Philippines is prone to natural and manmade disasters. Conscious recognition of this vulnerability brings to fore the key role that local governments must perform in disaster preparedness and mitigation;

WHEREAS, Local Government Units are mandated in Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, to ensure the safety and resiliency of communities to face the challenges of disaster;

WHEREAS, Section 524 of RA 7160 or the Local Government Code of 1991 states that each LGU shall conduct a periodic inventory of infrastructure and other community facilities and undertake the maintenance, repair, improvement, or reconstruction of these facilities;

WHEREAS, DILG Memorandum Circular No. 2011-47 enjoins all local chief executives to cause the immediate inspection and assessment of all local government infrastructure projects and buildings relative to their strength, rigidity and resistance to wind and seismic loadings;

WHEREAS, for the smooth implementation of the said issuance, there is a need to constitute the Pasig City Infrastructure Audit Team;

NOW, THEREFORE, I, VICTOR MA. REGIS N. SOTTO, City Mayor of Pasig City, by virtue of the powers vested in me by law, do hereby order that:

SECTION 1. COMPOSITION. The Pasig City Infrastructure Audit Team shall be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS. The Team shall perform the following duties and functions:

1. Identify through the use of various hazard maps the vulnerabilities of different infrastructures to various natural hazards as earthquake, typhoon, landslide/mudslides/rockslides and flooding;
2. Conduct regular infrastructure audits of government facilities within Pasig City;
3. Submit report/s on structural and non-structural defects or signs that should be noted during inspections; and
4. Recommend engineering procedures to various types of defects.

SECTION 3. SECRETARIAT. The CDRRMO is designated as the Head of the Secretariat to be assisted by the Office of the Building Official. The Secretariat shall provide all the necessary secretariat services to the Team.

SECTION 4. MEETINGS. The Team shall meet on a quarterly basis or as often as necessary.

SECTION 5. FUNDING REQUIREMENTS. Utilization of the part of the seventy percent (70%) preparedness fund of the five percent (5%) DRRM budget is authorized for the conduct of the infrastructure audit and identification and implementation of solutions to possible infrastructure issues in the city.

SECTION 6. REPEALING CLAUSE. All orders, rules and regulations, issuances or any parts thereof which are inconsistent with the provisions of this Order are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately
